Subject: Request for loading of FIR case regarding looting and ransacking/burnt down  
Of my house/shop located at Churachandpur on 3<sup>rd</sup> May 2023.

Sir,

I, the undersigned have the honour to state that large number of innumerable  
Unidentified groups of people belonging to Kuki community with deadly weapons and  
sophisticated arms including kuki militants groups stormed to all Meitei Inhabited  
areas of Churachandpur Town on 3<sup>rd</sup> day of May 2023 at around 4.30 pm.

The said unidentified groups vandalized/burnt down my house/shop and looted all  
valuable items. In that unfortunate incident, I have lost a total amount of Rs. 72,00,000/- (approx)

After the said unfortunate incident/mob violent, my family are fleeing our village and  
my family is taking shelter at a relief camp (Ideal Girls' Collage) situated at Akampat,  
Imphal East District, Manipur.

It is, therefore, prayed that the respected Sir may kindly initiate and take  
necessary legal action(s) against the accused persons and the persons involved in the  
said inhuman acts and heinous crime committed by the accused person and persons  
involved as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
