I have the honour to report that, on 03/05/2023 at around 8:30 pm, one RCC building G+1 located at Thengra Leirak, Churachanpur Dist. Manipur which is belongs to my son namely Robin Toijam aged about 38 years having Aadhaar no.3536 4244 1964, who is serving as Deputy Commandant of BSF and presently posted at 25th Battalion Delhi was set on fire by Kuki tribes rioters with Kuki militant by holding gun, sword, stick etc. and looted household items viz. some Gold ornament worth Rs. 5 lakhs, 4 nos. of cooking gas cylinder, one TV set, one Washing Machine, one Fridge, four beds, one sofa set, one dining sets, two iron godrej, three wooden almirah, and original certificate and other important documents including land patta. The approximate value of the lost house and household items is Rs. 1,10,00,000/- (Rupees one crore ten lakhs) approx. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is therefore requested you to kindly take up necessary action against those Kuki tribes rioters for their illegal and brutal acts as per law.
