


Subject:- Report.

Sir,

I have the honour to report that, I am born and brought up at Thengra Leirak, Churachanpur Manipur and living with my family of 5 members. I am a businessman by profession. On i.e. 03/05/2023 at around 8:30 pm, one of my house RCC G+1 comprising of 3 rooms located at Thengra Leirak, Churachanpur was set on fire by Kuki tribes rioters and Kuki militant by holding gun, sword, stick etc. and looted household items some Gold ornament worth Rs. 3,25,000/- (three Lakh twenty five thousands), 5 nos. of cooking gas cylinder, one TV, one Washing Machine, one Fridge, three beds, one sofa set, one dining sets, two iron godrej, two wooden almirah, and 70,000/- (seventy thousands) in cash including many important documents viz. Land patta and certificates. Further, they also burned down my iron workshop located at my locality including four welding machine, one stand drill, one Grinder, two cutter machine, two hand drill, two hand grinder and some iron worth Rs 50,000/- (fifty thousands). The approximate value of the lost house, household items and Iron workshop is Rs. 85,00,000/- (Rupees eighty five lakhs) approx. Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is therefore requested you to kindly take up necessary action against those Kuki tribes rioters for their illegal and brutal acts as per law.
