

I have the honour to state that since 40 years back, I have been staying at the rental house of one Mairembam Leimahal Devi located at Mandop Leikai, Churachandpur.

That, on 3/5/2023 at around 8:30 pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militants groups stormed to all Meitei inhabited areas of Churachandpur Town. The said unidentified groups vandalised/burnt down my rental house and looted all valuable items and also Rs. 2 lakhs in cash. In that unfortunate incident, I have lost a total amount of Rs. 10,00,000/-(Rupees ten lakhs). Their illegal act lead many properties turned into ashes and disturbing peace and tranquilities to the general public heavily.

It is, Therefore, prayed that the respected Sir may kindly initiate and take necessary legal action(s) against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law of the land as early as possible
