With due respect, I the undersigned would like to report the following for your kind favour and consideration and necessary action.

That, my vehicle namely 7 ½ Ton Tipper B/Regn. No. MN04A 4853, Chassis No. 344091BTQ105812, Engine No. 105813, which was kept at the resident of the Driver namely Sanatomba of Tengdongyang, Under Sekmai PS due to the prevailing Law and Order Situation of the state was forcibly driven out from the Driver's residence by unknown mob suspected to be Volunteers of Tengdonyang Youth Club and was later burnt down on 8th June,2023 at around 1:00 PM at Tengdongyang Village on NH-2.
