Subject: Report.

Sir,

I have the honour to state that, on 04-07-2023 at around 04:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000 persons carrying sophisticated weapons like AK, SLR, INSAS and .303 rifles forcefully entered our Village, at Khongnangpokpi Village, Kangpokpi District, Manipur about 24 Km South west from Saikul-PS. After looting all the moveable properties alongwith all the Cattles, Furnitures, Electric and Electronic appliances, Utensils, Clothes, Kitchen wares, Ornaments, Jewellery, Books, food and grains etc. They burnt down my house to ashes leaving us homeless. The approximate value of lost property is calculated at about Rs. 15,00,000/- (Fifteen lakhs).

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
