With due respect, I, the undersigned, beg to report to your good office that the Progressive People's Organization (PPO in short) having its Head Office at Singjamei Sougrakpam Leikai, Imphal West, has been working for more than 20 years under the Manipur State AIDs Control Society (MACS) and National Aids Control Organisation (NACO) and has so far been discharging duties in Churachandpur with a view to eradicating the drugs menace and for bringing to normalcy the sex workers who had already been ostracized by the society.

It is reported that on 4-5-2023 around 4.30 pm, a large number of Kukis holding deadly weapons like guns, daggers, sticks, etc. surprisingly stormed into the staff quarter of the "CORE COMPOSITE T.I. PROJECT", being run by the Progressive People's Organization (PPO in short having its Head Office at Singjamei Sougrakpam Leikai, Imphal West), at Zou Veng, Khuga Tampak Meitei Leikai under CC.Pur Police Station, Churachandpur District, and looted all the properties and materials kept inside the said quarter and subsequently set the said quarter on fire. The properties and materials of the said quarter either looted or set on fire in that event are : (1) Wooden Bed 6 in nos, (2) Gas cylinder 3 in nos, (3) Gas stove 1 in no, (4) Flat T.V. (Samsung) 1 in no, (5) DVD Player 1 in no, (6) Wooden Table 3 in nos, (7) Wooden Bench having handles 2 in nos, (8) Plastic Chairs 10 in nos, (9) Dining Table 1 in no, (10) Dinning Chairs 8 in nos, (10) Utensils - 3 pressure cookers, plates, bowls, still glasses, etc.(11) Mattress 6 in nos, (12) Syntex (Water Container) of 1000 lits 3 in nos, (13) Syntex (water container) of 100 lits 3 in nos, (14) Condom Box (containing 6 thousand pieces per box) 4 in nos, (15) 1 ml Syringe 4,000 in nos, (16) 2 ml syringe 1500 in nos, (17) Kambles 8 in nos, phaneks, lady shirts, etc. (18) Laptop 1 in no, (19) Wooden Almirah 2 in nos. (20) MI Mobile Phone Handset 9 Pro Max 1 in no along with sim card, (21) Stand Fan 2 in nos., (22) 7 nos of printer ink catridges.

It is further humbly reported that on the following day, i.e. 5-5-2023 around 11 a.m., a large number of Kukis further broke into the office room of "FEMALE INJECTING DRUGS USERS" which is used as Drop-in-Centre (DIC) at Zenhang Lamka, Old Bazar, CC.Pur, and looted all the properties and materials kept inside the said office. The materials looted from the said office are: (1) Laptop 3 in nos – 1 Lenovo, 1 Samsung nd 1 Ashus, (2) Wooden rack 4 in nos, (3) Steel Rack 2 in nos, (3) HP Laser Printer 1 in no, (4) Zerox machine 1 in no, (5) Wooden table 5 in

Chief Functionery.
The Progressive People's
