Sir,

I, the undersigned have the honour to state that a large number of unidentified people belonging to the Kuki community with deadly weapons and sophisticated arms including Kuki militant groups stormed the Meitei inhabited areas of Kanglatongbi under Sekmai P.S Imphal West District on 18<sup>th</sup> day of May, 2023 at about 11:30pm. The said unidentified groups vandalized our rented house and looted our household materials. In such terrible acts of the said unidentified groups, I along with my family members ran away from Kanglatongbi, Imphal West District on 19/05/2023 to save our life and taking shelter at different places of Yairipok. And started staying at the relief Camp of Thamballeima High School, Iramsiphai Leirak Ashangba since 31/5/2023. In that unfortunate incident I have lost my rented house and property amounting to a total amount of Rs:- 5,00,000/- (Five Lakhs) only.

It is therefore, requested kindly initiate and take necessary legal actions against the accused persons involved in the said inhuman and barbarous act, as per law of the land as early as possible. I couldn't able to submit my complain report in time due to prevailing inconvenient situation.
