

Sir,

With due respect, I have the honour to report the following few lines that on 7th July 2023 at around 11:00 am, some unknown persons suspected to be Kuki militatnts opened fire towards Meitei populace area of Chirik Loitong Village, Tingri and burnt down, vandalised and looted many houses of Meitei.

In that, the Kuki armed militants had trespass my house and all household properties like furniture items, kitchen items, utensil items, clothing, electronic items and others were looted as well as vandalised/burnt down my house by the militants. The approximate value of burnt down/looted properties are estimated at ₹ 1,27,300/- (One lakh twenty seven thousand three hundred only) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence I therefor reported to your good office for further procedure.

It is therefore requested that you kindly look into the matter and take up necessary action at the earliest
