Sir,

I have the honour to report that large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including kuki militant groups stormed to all Meitei inhabited areas of Churachandpur Town on 3/5/2023 at around 4:30 pm. The said unidentified groups burnt down my house cum shop and also looted all valuable items. In that unfortunate incident, I have lost a total amount of Rs. 4500000. After the said unfortunate incident/mob violent, my family are fleeing our village and my family is taking shelter at a relief camp situated at Wangjing, Thoubal District, Manipur.

It is therefore, requested to take necessary legal action against the accused persons and persons involved in the said inhuman acts and heinous crime committed by the accused persons and persons involved as per law.
