Subject: - Report.

Sir.

With due respect, I have the honour to report the following few lines that on 29th June, 2023 at around 1:00 pm, some unknown person suspected to be Kuki militants opened fire towards Meitei populace area of Leimakhong Premnagar and vandalized many houses of Meitei. In that, the Kuki arms militant had trespass and vandalized my younger sister namely Oinam Sarita Devi 40 yrs W/o. Sarangthem Hritesh Singh house and all household properties like furniture items, kitchen items, utensil items, clothing, electronics items, jewelry items and others were looted as well as vandalized her house by the militants. My younger sister along with her family members had left her home since last week of April, 2023 and presently staying at Jamu after proper locked and key of her house. The approximate value of looted properties are estimated at Rs.20,00,000/- (Rupees twenty lakhs) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
