In that, the Kuki arms militant had trespass my house and all household properties like furniture items, kitchen items, utensil items, clothing, electronics items and others were looted as well as vandalized/burnt down my house by the militants. The approximate value of burnt down/looted properties are estimated at Rs.1,31,6000/- (Rupees One lakh thirty one thousand six hundred only) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
