> OFFICER WORARGE SEKMAI POLICE STATION IMPHAL WEST DISTRICT

Sir,

1. On 3rd May 2023 at approx 1800hrs Assam Rifles was requisitioned by the Govt of Manipur received through DC KPI for Aid to Civil Authority.

- On 05 May 2023 during night at approx 2000hrs onwards, while operating in aid to civil authority, own troops had to resort to firing in the Air to disperse unidentified personals/ANEs.
 The details of incidents are in succeeding paras.
- 3. IS Duty columns of Assam Rifles were launched to contain the situation, due warning was given by own troops to disperse the crowd. Thereafter, own columns warned them in vernacular, English & Hindi language.
- 4. Violent rioters has gathered near Key Stone Factory, Sekmai & large mob had gathered at Key Stone Factory, Sekmai. The agitated crowd had already burnt few vehicles, amidst stone pelting and were carrying out firing using weapons. Own columns were carrying out rescue of Internally displayed civilians and during the process of rescue the vehicular convoy encountered a road block & was ambushed by unknown miscreants with Small arms fire and stone pelting near Key Stone Factory, Sekmai. As the column advanced it was fired again and a Civil bus carrying the Civilians was punctured by the miscreants. On moving few kilometres ahead near Sekmai the column encountered two more road block with burning tyres and boulders on the road amidst stone pelting and mob carrying flame torches and firing at owr parties. Sensing grave danger to life of innocent civilians & insurmountable threat to Gov property, controlled Fire in air was carried out by own columns as last resort to disperse the unlawful assembly after adequate warning as legally mandated thereby, controlling the aggravating situation in time saving precious lives and preventing any collateral damage.
- 5. Assam Rifles columns carried out search of the area after the controlled fire in air & dispersal of crowd to look for injured persons and provide medical aid & evacuation. There were no injured person at the location. NO casualty of civilians reported.
- 6. You are requested to kindly file a FIR on the incident against unidentified armed rioter for attempt to murder with deadly weapons, to deter public servants suppression riots, causin hurt with dangerous weapons, destruction of public property rioting and disturbing peace.
