I was residing at Khumujamba Meitei Leikai, Churachandpur District. The said unidentified groups vandalized/burnt down my house/resident and looted all valuable items. These main items are an Alto Car, two gas cylinder, refrigerator, washing machine, TV, other household items. In that unfortunate incident, I have lost a total amount of Rs. 500,000/- (Five Lakhs). After the said unfortunate incident/mob violent, my family are fleeting; our family has sheltered at different relief camps organized by State government and local bodies and now staying at our own house.

It is, therefore, prayed that the respected Sir may kindly initiate and take necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime.
