Sir,

I, Konjengbam Rajesh Singh have the honour to state that the large number of innumerable unidentified groups of people belonging to kuki community with deadly weapons and sophisticated arms including Kuki militants groups stormed to all Meitei inhabited areas of Churachandpur town on 3rd of May 2023 at around 2 pm. The said unidentified groups vandalised/burnt down my House and shop and looted all the valuable items. In the unfortunate incidence, I have lost a total sum of RS 30,00000/- After the said incident /mob violent, my family are fleeing our village and family was taking shelter at a relief camp(Lamding Higher secondary school) situated at Wangjing Lamding, Thoubal District.

It is, therefore prayed that the respected sir kindly initiate and take necessary legal action(s) against the accused persons and the person involved in the said inhumane acts and heinous crime committed by the accused persons and the persons involved as per law of land as early as possible.

I shall be grateful for your kind co-operation and necessary action(s).
