

Subject:- Report on attempt to murder.

Sir,

I, the undersigned, have the honour to state the following for your kind intervention and favourable action:

1. That, I, Mr. Liansonmuang aged about 23 Years of age S/o Liankam a permanent of New Lane, Bungmual, New-Lamka, Churachandpur, Manipur-795128.
2. That, at about 04:00 pm on the 04th of May 2023, due to the indiscriminate gunfire upon the masses by the armed radicals belonging to the meitei/meitei community from Zoveng area, upon the tribal netizen, where there ensued a chaos and during such a commotion I, while running towards safety, sustained injuries by one JCB approaching towards the commotion.
3. That, till date I have been undergoing major surgeries twice, and so far has been under observation in the Churachandpur District Hospital.
4. That, it may also be reported here that the Meitei/meitei armed radicals shouted anti tribal slogans while releasing indiscriminate fire upon the unarmed tribal netizens on the open road.

Being a victim of ethnic attack by the dominant and majority Meiteis, I am filing this report with a request to kindly take necessary legal action against the perpetrators as per law.
