Today the 27th May, 2023 at 6:00 pm, received a reliable information that at around 5:30 pm of the same day, an armed encounter took place between 2(two) unknown armed groups at Suongdo Village area, Churachandpur in which one unknown person was killed at the spot and two unknown persons were injured. The deceased and the injured persons were taken/ evecuated to District Hospital, Churachandpur. The deceased was later identified as Mr. Jamkhothang Touthang (41) years of Chavangphai near Suongdo village and the injured persons were also identified as 1). Mr. Hauminthang 16 years of Gollenkot villlage, Henglep and 2). Gogou 19 years.

Hence, a suo moto case under FIR NO.182(05)2023 CCP-PS u/s 302/307/326/34 IPC & 25(1-c) Arms act has been registered against the 02(two) unknown armed groups for investigation.
