
Sir,

I have to report that last evening  
(27<sup>th</sup> May, 2023) at around 9:30pm, while  
I was having a meeting with my  
officers on prevailing law & order situation  
at my office, some 150 to 200 miscreants  
stormed my office and our power our office  
guards and escorts. They were demanding  
firearms and ammunition, but we somehow  
manage to reason and escape from the scene  
by telling them that we will be heading  
towards a border village called Aohel to  
assist the already existing manpower of  
ours. As the miscreants are quite emotional  
about the current social turmoil, we could  
somehow manage to escape from office without  
losing any arms and not firing a bullet.
