With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That, on 3rd May, 2023 at around 10:30 pm, unknown miscreants suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun numbering about 300-500 burnt down my house i.e. at Kangvai Churachandpur, District, Manipur, PO & PS- Churachandpur. The value of damage properties is estimated to be about 40 lakhs approx.

I could not report the incident to my concerned police station as well as in time due to the prevailing law and order situation in the state.

I therefore request your good office to kindly take up necessary action in this regard.
