Sir,

With due respect and regard, I am to report that on 03/05/2023 at about 9:30 pm my house constructed as Semi Pucca was totally set on fire by a large number of people of Kuki tribe. In the fire incident the following properties have been totally damaged. 1) Semi pucca house cost about Rs. 25 lakhs, (2) Furniture cost about Rs. 5 Lakhs, (3) Rs. 4 (four) Lakhs in cash, (4) 4 mohar of Gold cost about Rs. 2,40,000/- (5) Activa 4G cost Rs. 65,000/-. Total damaged are Rs. 37,05,000/- (Rs. Thirty seven lakhs and five thousand only). Due to law and order situation I could not be submitted the report to concerned PS and presently self and my wife namely N (O) Kabita Devi (27)yrs. along with my daughter namely N. Anjali (1 month) is taking shelter at the house of Haobam (O) Tombi Devi W/o (L) H. Chaoba of Yairipok Khoirom Mathak Leikai, PS Yairipok.

It is therefore requested to take necessary action against the culprits according to law.
