Sir, With due respect and humbly I the undersigned  
would like to state some few lines before you for your  
kind consideration and necessary action.

That, on the 3<sup>rd</sup> May 2023 at around 8:00 PM, unknown  
miscreants belonging to Arambai Tenggot, Kangleipak Kanba  
Lup and Meitei Leepun numbering about 200-300 stormed  
into my campus and destroyed, looted and burned down  
my house which includes household items, furnitures, land  
pattas, books, electronic items, valuable clothes and other items  
worth approximately about 10 (ten) lakhs at Dopkon, Churachandpur  
district, Manipur 795128 under Churachandpur Police Station.

I couldn't report the incident to my concerned police stat  
as well as in time due to the prevailing situation in the  
State.

I therefore request your good office to kindly take necess  
any action in this regard.
