I have honour to report that today i.e. 03/08/2023 at @ 5:40 am heard some sounds of gun firing from Haraothel and Koutruk area and as such I make my team alert at our post i.e. at Senjam Chirang Water Supply. At @ 9:00 am one Rfn. No. 062000308 of 6th MR namely Tourangbam Rishikumar 48 yrs S/o (L) T. Modhuchandra of Wangjing Lamding Mamang Leikai received bullet injury on his head fire out by Kuki Militant from the Haraothel side suspected to be fire by sophisticated weapon like Sniper gun while he was at corridor of barrack inside our post campus. As a result of which he received injury on his person and evacuated to Raj Medicity Hopital for medical treatment. He is now undergoing treatment at the said hospital.
