Sir,

With due respect, I have the honour to report the following few lines that, my mother namely Khwairakpam Snahal Devi 56 yrs W/O. Late Kh. Shanti Singh a residence of Leimakhong Chingmang, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. On 04/05/2023 at around 4:00 pm some unknown person suspected to be Kuki militants and Kuki rioters opened fire towards Meitei populace area of Leimakhong Chingmang village, IW district and torched many houses and vandalized of Meitei. In that, the Kuki arms militant and Kuki rioters had trespass my mother rented grocery shop and looted all grocery items by breaking the Lock and key which she had locked. The approximate value of looted & vandalized properties are estimated at Rs. 10,00,000/- (Rs. Ten Lakhs and) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
