Sub - Report on arson and house picketting.

Sir,
With due respect and humbly I the undersigned would like to state some few lines before you for your kind consideration and necessary action.

That, on the 3rd May 2023 at around 8:00 pm, unknown miscreants belonging to Asambai Tenggot, Kangleipak Kamba Lup and Meethi Leepun numbering about 200-300 stormed into my campus and destroyed, looted and burned down my one storey building which includes household items, furniture, land pattas, books, gun license, electronic items, valuable clothes and other items worth approximately about 89 (eighty nine) lakhs at Dopkon, Churachandpur district, Manipur 795128 under Churachandpur Police Station.

I couldn't report the incident to my concerned police station as well as in time due to the prevailing situation in the state.

I therefore request your good office to kindly take necessary action in this regard.
