Sir,

I, the undersigned, would like to report that today i.e. 27-05-2023 at around 2:30 a.m., security barracks located inside the premises of 132/33 KV Khengjang Power Sub-station, Ccpur, was attacked, vandalized and set afire by unknown miscreants.

That, there are 3(Three) security barracks (each measuring about 48x15 feet) within the premises of the power sub-station in which one of the barracks was set on fire and every article inside it were left to ashes while the remaining two barracks were dismantled by the unknown miscreants.

It is, therefore, requested to kindly take action under appropriate section of law.
