Sir,

With due respect, I have the honour to report the following few lines that, I am a residence of Leimakhong Chingmang, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. On 29/06/2023 at around 1:30 pm some unknown persons suspected to be Kuki militants opened fire towards Meitei populace area of Leimakhong village, IW and torched many houses and vandalized of Meitei. In that, I along with my family members have come out from our residence and taking shelter at Khurkhul Awang Leikai Relief Camp, IW by keeping my house under locked and Key. On 30/07/2023 it comes to light that, the Kuki arms militant had trespass my house and looted all my properties i.e. furniture items, kitchen items, utensil items, clothing, electronics items, 15 bags of rice and domestic animals by breaking the lock and key which I had locked. The approximate value of looted & vandalized properties are estimated at Rs. 1,50,000/- (Rs. One Lakh Fifty Thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

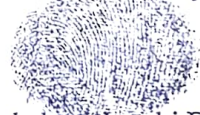
It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
