Sir,

With due respect, I have the honour to report the following few lines that, I along with my family members were staying at the rented house of one Yangneikup (owner) at Leimakhong Chingmang, IW district since last 20 years back. Also running a tailoring cum Cosmetics items shop at the said rented house. However, On 29/06/2023 at around 1:30 pm some unknown person suspected to be Kuki militants opened fire towards Meitei populace area of Leimakhong Chingmang village, IW district and torched many houses and vandalized of Meitei. In that, I along with my family members have come out from my residence and taking shelter at Khurkhul Awang Leikai Relief Camp, IW by keeping my house under locked and Key. On 30/07/2023 it comes to light that, the Kuki arms militant and kuki rioters had trespass my shop and looted all my properties i.e Cosmetic items and 2 nos of Ice cream Machine, tailoring items by breaking the Lock and key which I had locked belonging to me. The approximate value of looted & vandalized properties are estimated at Rs. 40,000/- (Rs. Forty Thousand) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
