Sir,

With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that incident, the Kuki armed militant had trespass my house and looted many household items such as electronic items, jewellery, kitchen items, furniture items, domestic animals (4 cows, 10 ducks). Around 30 numbers of broiler chicks which is 35 days old had been looted and 1400 chicks had been killed. A shed of broiler chicks of dimension 20ft X 70ft had been destroyed on the incident. The approximate value of looted properties is estimated around Rs. 15,00,000/- (Rupees Fifteen Lakh) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
