On 03/05/2023 at around 4:20 pm some unknown person suspected to be Kuki militants and Kuki rioters opened fire towards Meitei populace area of Leimakhong Exservicemen colony, IW district and torched many houses and vandalized of Meitei. In that, I along with my family members have come out from my residence and taking shelter at my son-in-law house, Yaiskul police Lane, IW by keeping my house under locked and Key. On 01/08/2023 at 2:20 pm, it comes to light that, the Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, clothing & electronics items by breaking the Lock and key which I had locked and vandalized some portion of my house.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
