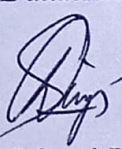

With due respect, I have the honour to report the following few lines that, I am a resident of Leimakhung chingmang Ex-Service colony, 1W district which is under the control of kuki arms militants since the beginnings of the current communal riots. Due to the ongoing communal crisis between two communities. On 4/05/23 at around 4.20 am, I along with my family members have come out from my residence and taking shelter at Kanto Hakha leikai community hall relief camp, 1W by keeping my house under locked and key. On 04/08/2023 at 7.10 ~~pm~~ pm, it comes to light that, suspected to be the kuki arms militants and kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, electronics items and clothing items by breaking the lock and key with I had locked.

Regarding the matters I couldn't able to report till date due to the present situation in the state. Hence, I therefore reported to your good offices for further procedure.

It is therefore requested you to kindly look into the matter and take up necessary action at the earliest.
