

With due respect, I have the honour to report the following few lines that I am a residence of Leimakhong Ex-Servicemen Colony, IW District which is under the control of Kuki arms militants. Since the beginning of the current communal riots, Due to the Ongoing Communal Crisis between two communities, On 04/05/2023 at around 4:20am, I along with my family members have came out from my residence and taking shelter at Kanto Matka Leikai community Hall relief camp, IW by keeping my house under locked and key. On 04/08/2023 at 6:50 pm, it comes to light that, suspected to be the Kuki arms militants and Kuk? rioters had trespass my house and looted my properties, i.e. furnitures items, kitchens items, utensil items, clothing and electronics items by breaking the lock and key which I had locked,

Regarding the matters I couldn't able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
