Due to the ongoing communal crisis between two communities. On 4/05/2023 at around 6:00 am, I along with my family members have come out from Leimakhong Ex-Servicemen colony and taking shelter at Kanto Makha Leikai Community hall Relief camp, IW by keeping my house under locked and Key. On 29/07/2023 at 12:10 pm, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted/Vandalized my properties i.e furniture, kitchen, utensil, clothing & electronics items by breaking the Lock and key which I had locked.


Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
