On 06/08/2023 at 8:00 pm, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted/Vandalized my properties i.e furniture, kitchen, utensil, clothing & electronics items by breaking the Lock and key which I had locked. The approximate value of the properties is Rs 17,00,000/-(Rupees seventeen lakh)

Regarding the matters I couldn't able to report till date due to the present\* situation in the states. Hence, I therefore reported to your good office for further procedure.
