The approximate value of the properties is Rs. 3,50,000/-(Rupees Three Lakh fifty thousand)

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
