With due respect, I have the honour to report the following few lines that, I am a residence of Leimakhong Chingmang, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. Due to the ongoing communal crisis between two communities. On 4/05/2023 at around 5:00 am, I along with my family members have come out from my residence and taking shelter at my sister house located Khurkhul Makha Mayai Leikai, IW by keeping my house under locked and Key. today i.e 09/08/2023 at 7:30 am, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted/Vandalized my properties i.e furniture, kitchen, utensil, clothing & electronics items, cash and jewelry items and others by breaking the Lock and key which I had locked. The approximate value of the properties is Rs. 18,50,000/- (Eighteen lakh fifteen thousand).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
