- 2. Kitchen items Rs. 50,000/-
- 3. Furniture Rs. 80,000/-
- 4. Garments Rs/ 45000/-
- 5. Electronics Rs. 60,000/-
- 6. Important documents were looted.

Total value is about Rs. 10,45,000/- approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
