On 07/07/2023 at 8:00 pm, it comes to light that, suspected to be Kuki arms militant and Kuki rioters had trespass my house and grocery shop and looted my grocery items by breaking the lock and key. The approximate value of the properties is Rs. 2,00,000/- (Rupees two lakhs) Only.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
