

With due respect, I have the honour to report the following few lines that on 29<sup>th</sup> May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that incident, five number of cows had been killed by the Kuki militants. The approximate value is estimated around Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
