In that incident, five number of cows had been killed by the Kuki militants. The approximate value is estimated around Rs. 1,20,000/- (Rupees One Lakh Twenty Thousand) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
