With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that, two numbers of cow had been killed. Several bullets had reached the Kanto Sabal village too, due to the reason broiler chicks around 1500 which was 30 days old has died. The approximate value of lost properties is estimated around Rs. 4,20,000/- (Rupees Four Lakh Twenty Thousand) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
