On 08/08/2023 at 8:00 am, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass the said rented house and looted my belongings properties i.e. furniture, kitchen, utensil, clothing & electronics items by breaking the Lock and key which I had locked. The approximate value of the properties is Rs.10,00,000/-(Ten Lakh).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
