With due respect, I have the honour to report the following few lines that, I have staying at the rented house of one Hapy (owner) at Leimakhong Chingmang IW district since last 11 years back. Due to the ongoing communal crisis between two communities. On 19/05/2023 at around 11:00 am, I have come out from the said rented house and taking shelter at Kanto Makha Leikai Relief Camp, IW district by keeping under locked and Key. On 08/08/2023 at 8:00 am, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass the said rented house and looted my belongings properties i.e. furniture, kitchen, utensil, clothing & electronics items by breaking the Lock and key which I had locked. The approximate value of the properties is Rs.10,00,000/-(Ten Lakh).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
