Due to the ongoing communal crisis between two communities. On 3/05/2023 at around 12:00 pm, I have come out from my residence and taking shelter at Kanto Makha Leikai Relief Camp, IW by keeping my house under locked and Key. On 02/08/2023 at 9:00 am, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e. furniture, kitchen, utensil, clothing & electronics items and rice mill machine and others by breaking the Lock and key which I had locked. The approximate value of the properties is Rs.20,00,000/-(Twenty Lakh).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
