Due to the ongoing communal crisis between two communities. On 3/05/2023 at around 6:00 pm, I along with my family members have come out from my residence and taking shelter at Kanto Makha Leikai Relief Camp, IW by keeping my house under locked and Key. On 02/08/2023 at 3:20 pm, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and looted my properties i.e furniture items, kitchen items, utensil items, clothing items, electronics items and also vandalized some portion of my house. The approximate value of the looted properties are estimated at Rs. 20, 00000/- (Rupees twenty Lakh).

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
