

Sir,

With due respect, I have the honour to report the following few lines that on 6th July, 2023 at around 4:30 pm, some unknown person suspected to be Kuki militants opened fire towards Meitei populace area of Chirik Loitong, Tingri and bunt down, vandalized, looted many houses of Meitei. In that, the Kuki arms militant had trespass my farm and all household properties, like furniture items, kitchen items, utensil items, clothing, electronics items, 6 bundle of tin (zine), 5 bags urea fertilizer, 150 bee box, 40 paddy bags and domestic animals (5 Oxen, 4 goat, 85 hen, 15 duck) others were looted as well as vandalized/burnt down my house by the militants. The approximate value of burnt down/looted properties are estimated at Rs. 20,00000/- (Rupees twenty lakh) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
