


Sir,

With due respect, I have the honour to state that I am a MES (Military Engineering Service) contractor and I am constructing a Building block at "27 R&O Flight" located at MES (Military Engineering Service), Leimakhong Army camp. On 10/08/2023 at around 3:30 pm one of my worker ring me up on my mobile phone and informed me about the shortage of construction material and on same day I went to my work place i.e. at "27 R&O Flight" located at MES (Military Engineering Service), Leimakhong Army camp along with the construction materials. While reaching Army check post no. 3 (302 ASC Company) located at Leimakhong Premnagar, Ex-Servicemen Colony 6 (six) persons suspected to be Kuki Militant, two of them were in full Como flack uniform wrongfully detained me and asked me that are you Meitei? also threaten me by saying that they will kill me further they forcibly try to take me to Leimakhong hill areas in front of duty personnel of check post no. 3. Later on Army personnel who were on duty at check post no. 3 rescued me and drop me upto safe area.


It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
