Sir,

With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that, three numbers of cow, two numbers of goat had been killed. Several bullets had reached the Kanto Sabal village too, due to the reason broiler chicks around 1800 which was 28 days old has died and 950 chicks which was around 43 days old. The approximate value of lost properties is estimated around Rs. 8,94,000/-(Rupees Eight Lakh Ninety Four Thousand) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
