Sir,

With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of Engourok Chingmang, Kanto Sabal and vandalized many houses of Meitei. In that incident, two numbers of cow, 19 numbers of piglet which was 2 months old had been killed by the Kuki militants. The approximate value of looted properties is estimated around Rs. 2,00,000/- (Rupees Two Lakh) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
