

With due respect, I have the honour to report the following few lines that, I am a residence of Kanto Prem Nagar, IW district which is under the control of Kuki arms militants since the beginning of the current communal riots. On 4/05/2023 at around 12:20 pm, I along with my family members have come out from my residence and taking shelter at Kanto Awang Leikai Relief Camp, IW district by keeping under locked and Key. On 01/08/2023 at 8:30 am, it comes to light that, suspected to be the Kuki arms militant and Kuki rioters had trespass my house and vandalized some portions of my house as well as looted my belongings properties i.e. furniture items, kitchen items, utensil items, clothing items & electronics items by breaking the Lock and key which I had locked. The approximate value of the properties is Rs.10, 00000 /- (Rupees Ten Lakh).


Regarding the matters I couldn't able to report till date due to the present situation in the states. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
