With due respect, I have the honour to report the following few lines that on 29th May, 2023 at around 1:10 pm, some unknown persons suspected to be Kuki militants open fired towards Meitei populace area of EngourokChingmang, Kanto Sabal and vandalized many houses of Meitei. Several bullet had reached Kanto Sabal village too, due to the said reason, 1500 broiler chicks which was 30 days old died the estimated value of the lost properties. The approximate value of lost properties is estimated around Rs. 4,00,000/- (Rupees four Lakh) approximately.

Regarding the matters I couldn't be able to report till date due to the present situation in the state. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
